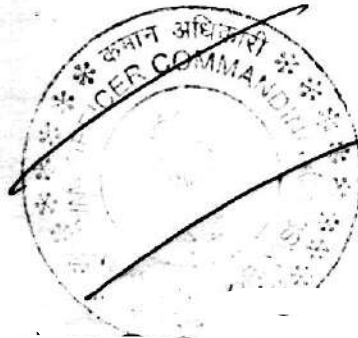

2. Actual number of condemned OBMs/Vessels/Misc items may be increased during the auction without prior intimation to bidders.
3. All the interested bidders may attend the auction on the date and time given above and register their name after depositing Rs.50,000/ (Rupees fifty thousand) only in cash as bid security before the bids, which will be refunded or adjusted after finalization of auction.
4. Successful bidder has to deposit 25% of the bid value plus GST as per applicable under rules in cash on the spot immediately after finalization of auction. Remaining 75% of the auction value will be deposited within 10 days from the auction day. If failing which 25% amount which was already deposited by the successful bidder will be forfeited and condemned stores will be placed for auction again after obtaining approval of the competent authority.
5. Before lifting all the stores, successful bidder should deposit full bid value of condemned stores (including GST). In case the final bidder fails to deposit the cost of stores within 10 days, his bid security will be fortified and board may consider for sale the stores to next highest bidder/next auction.

6. All bidders will have to furnish copy of income tax clearance certificate, copy of PAN card, GST No. and Voter card /Aadhar card as address proof before commencement of auction.
7. Successful bidders will lift the auctioned stores from Water Wing BSF Bay Dhubri, Baluchar No.3, Distt- Dhubri (Assam)- 783301 within 10 days under his/their own arrangement and supervision. No transportation will be provided for shifting/lifting the auctioned boats/vessels under any circumstance.
8. IG BSF Guwahati Frontier through detailed board of officers will reserves the right to accept or reject any/ all the auction bids without assigning any reason or to withdraw any/entire lot of actionable stores/items before auction.
